November 2023 minutes approved

1. 3-8 Boys & Girls Basketball Update - Dink Horstman

Concerns around some candy items expiring soon. Discussion around items that don't sell well (chocolates, orange/purple powerade). Laura has been ordering exactly what

Louie had always ordered/is following recommendations from Louie regarding ordering; Board can look at inventory methods when Laura is present.
