## A GUIDE TO GIVING IN STEWARDSHIP

## God calls us to be generous with all of our gifts, including our treasure. Scripture teaches us this again and again:

"Honor the Lord with your wealth, with first fruits ..." (Prv 3:9)

"How can I repay the Lord for all the great good done for me?" (Ps 116:12)

"..this poor widow put in more than all the other contributors to the treasury ... she, from her poverty, has contributed all she had..." (Mk 12:43-44)

In gratitude, we are called to give to God from our first fruits regardless of the amount. That means creating a plan for giving to His Church. When we give only what's left over (tossing a last-minute donation in the basket) we often end up feeling frustrated or disconnected. But with a plan, we can give with intention, joy, and trust, doing our part to return a portion of the gifts God has given us.

## **BEST PRACTICES**

- Create and maintain a household budget
  - Plan your giving annually
- Use your parish's Online Offertory (if applicable)
- Understand that tithing literally means to give ten percent of your income. Suggested amounts: five percent to the local parish and five percent to other Church needs and charities that serve the greater community.

### ANNUAL GIVING OPPORTUNITIES



Whether giving weekly, monthly or yearly, the offertory supports the parish's mission and ministries.



Catholic Services Appeal Supports the immediate and urgent mission of the local Church, including ministries, parishes and schools.



Second Collections Supports the priorities of the pope and bishops through specific national and worldwide ministries.



*iGiveCatholic* Provides the means for parishes to carry out specific projects.



*Community Charities* Opportunities to support the mission of nonprofit organizations and other needs.
